WHO IS A CHILD WORKER?
A worker, who has turned 14, but not yet 15, and at the same time has completed eight years of basic education (4+4), is called a child worker.

CHILD LABOUR

Child labor is that children are too young to work or engage in dangerous activities that can harm their physical, mental, social or educational development

Normal work	Age of 15 years	Age of 14 years	Completed 15 years of age but not completed 16 years of age Maximum 40 hours per week
Hazardous work	Age of 18 years	Age of 16 years	Completed 18 years of age

Seasonal migratory agricultural work was defined as the worst forms of labor in the Republic of Turkey in the context of ILO Convention No. 182 Worst Forms of Child Labour Convention, and the working age was determined as 18 years and over.

WHO IS A YOUNG WORKER?

A worker who has turned 15, but not yet 18, is called a young worker.
